Proposed Institutionally-funded Scholarship/Grant-in-Aid Program of USTP- Claveria undergraduate students

Rationale

Education is vital in every individual. According to Dr. Ronald Meinardus, former president of the Friedrich-Naumann-Foundation in the Philippines the more and better educated the people, the greater the chances of economic development. He further said that literacy and numeracy play vital roles in any country's growth and progress.

This School Year 2018-2019, millions of college students in government-funded higher education institutions (HEIs) are expected to benefit in the Republic Act 10931, or the Universal Access to Quality Tertiary Education Act. Starting this year all tuition and other school fees will be covered, and this will apply to all students in SUCs, LUCs and technical and vocational institutions by the government. All students will be eligible to receive these benefits, provided they qualify under the admission and retention requirements of the SUCs and LUCs. This is of no distinction whether the student is bright or not bright. Section 6 of RA 10931extended the importance of scholarship – it stated that a unified, improved, and expanded government-funded Scholarship program shall be instituted to promote an environment conducive for the development of bright and talented students to serve the public good and enlarge the pool of world-class Filipino researchers, artists, innovators, thinkers, and leaders. The merit and talent-based Scholarships will serve as motivation to deserving students to excel in their respective courses.

1. To produce a pool of highly qualified graduates and technical experts who will contribute to the country's high-level labor force through merit and talent-based Scholarships




